It was moved by Rosen and supported by Alessandrini to excuse Member Farragh's absence.

### **Approval of Agenda**

Rosen asked that "Approval of City Park Usage Re: Youth Advisory Committee Easter Egg Hunt" and "Discussion of Bishop Baraga Catholic School Drop Off" be added as items number four and five, respectively, under New Business. It was moved by Moraska and supported by Alessandrini to approve the agenda, as amended.

*Minutes of the Regular Meeting of February 18, 2013*

It was moved by Villa and supported by Moraska to approve the Minutes of February 18, 2013, as prepared.

### **Public Comment**

*Cheryl Gerwig – 605 East E Street*

Gerwig requested that the City service her sewer line due to frequent freezing issues. Stanchina stated that the sewer line servicing Gerwig's home has been inspected and that the City's portion was found to be operational.

*Virginia Feleppa – 1136 Crystal Lake Boulevard*

Feleppa reported that 25 trees have been purchased through the City's tree program and encouraged residents to participate.

#### **Authorization to Allow YMCA to host Challenger Sports British Soccer Camp at Crystal Lake Field**

Stanchina presented the YMA's request to utilize the Crystal Lake Soccer Field to host a soccer camp.

It was moved by Villa and supported by Moraska to authorize the YMCA to use the Crystal Lake Soccer Field to host a Challenger Sports British Soccer Camp from June 24, 2013, to June 28, 2013, between 9:00 a.m. and 4:00 p.m.

#### **Authorization to Solicit Bids Re: City Hall Carpet Replacement**

Stanchina detailed the proposed carpet replacement project. Stanchina clarified that he can adjust the quantity of carpet ordered if the installation of tile becomes a consideration. He stressed the importance of not voiding the carpet's warranty with non-manufacturer approved adhesives.

It was moved by Rosen and supported by Alessandrini to authorize the solicitation of bids for City Hall carpet replacement.

### **Discussion of Parking and Storage of Recreational Vehicles, Trailers, Equipment and other items ordinance**

Stanchina communicated that the goal of this ordinance is to restrict the placement of recreational vehicles, trailers and equipment in front yards as pedestrian and vehicle access can be adversely affected. He imparted that the goal is not to prohibit the parking of unregistered snowmobiles as they may be used intermittently.

### **Approval of City Park Usage Re: Youth Advisory Committee Easter Egg Hunt**

Stanchina indicated that City Park would be open to the public during the event.

It was moved by Rosen and supported by Villa to authorize the usage of City Park for an Easter Egg Hunt on March 23, 2013, from 1:00 p.m. to 4:00 p.m.

### **Discussion of Bishop Baraga Catholic School Drop Off**

Rosen outlined the previous and current traffic concerns associated with the Bishop Baraga Catholic School Drop Off. Moraska objected to the idea of the Police patrolling this situation in a covert fashion.

#### *Julie Badini – 413 West A Street*

Badini noted that she has experienced difficulty in accessing her property over the past couple weeks due to the school drop off. She stressed that this has been an ongoing concern over the last several years.

Stanchina offered the suggestion that it would be preferable to change the signs in the alley to say “no stopping, standing or parking” as to allow optimal enforceability. It was concluded that once the no parking signs in the alley are updated, the catholic school principal will be informed of the date that the enforcement of alley availability will begin.
