Alley Vacation Request Re: Iron Mountain Public Schools

Rosen opened the public hearing.

James Marlett (Representative for Elayne Marlett) – 222 West B Street

Marlett objected to the proposed alley closure on the basis of potential property devaluation due to decreased accessibility.

Rosen closed the public hearing.

Sign Ordinance

Rosen opened the public hearing.

Bob Baker – W8062 Lake Antoine Road

Baker expressed the opinion that the sign ordinance, as presented, would increase the costs of doing business and therefore harm the local economy. He detailed several objections to the ordinance.

Benjamin Baker – Owner of Baker Sign Company

Baker indicated that he is not in support of approving the proposed sign ordinance due to its restrictive nature. He outlined his objections.

Larry Douglas – Perennial Gardens

He stressed the importance of utilizing off premise advertising for businesses that are not located on Stephenson Avenue.

Rosen communicated the opinion that the City should endorse the closure of the Lake Antoine Road to truck traffic during spring break up due to excessive pavement degradation. Alessandrini, Moraska, Villa and Jacobetti asserted that it would not be ideal to endorse the closure of the Lake Antoine Road to truck traffic due to the degradation of Stephenson Avenue's road surface, safety concerns and excessive speed. Rosen and Corombos supported the closure of the Lake Antoine Road to truck traffic in an effort to preserve the road surface.
