## **City Manager Reports**

#### ISO Public Protection Classification (PPC)

Stanchina announced that the Iron Mountain Fire Department has been rated a 4 by the ISO. He imparted that an increase in ISO rating can positively affect insurance premiums. The City Council communicated their appreciation for the City staff's efforts to receive the improved ISO rating and asked that a letter of appreciation be sent.

# Spring Solid Waste Drop-Off

Stanchina notified the City Council of the upcoming solid waste drop-off.

## City Park Skate Park

Stanchina conveyed that the City is in the process of having the DNR approve the quote for the blasting and repainting of the skate park equipment. He outlined the remaining items that must be completed on the project.

## August Election for County Operating Millage

Stanchina reported that Dickinson County is going to be placing a proposal on the ballot in August to increase their operating millage by 1.5 mills. He indicated that they are intending to reimburse the election costs. Revord requested that a written confirmation be provided regarding the County reimbursing election costs. Stanchina confirmed that the City is statutorily obligated to hold the election, despite the level of reimbursement.

#### River Avenue

Stanchina communicated that he is awaiting a response from the partners of Mouw and Celello regarding the determination of property boundaries over the former River Avenue property.

#### YMCA Expansion

Stanchina updated the City Council on the status of determining the cost of a replacement Little League ball field.

#### DDA Workshop

Stanchina detailed the redevelopment ready training he attended though the Downtown Development Authority. Blomquist voiced his support for the ideas that are contained within the redevelopment ready concept.

## Leaf Pick-Up / Street Sweeping

Stanchina reported that leaf pick-up is under way and that street sweeping is ahead of schedule.

## Paving /Potholes

Stanchina verified that he is planning to address potholes within the alleys.

## Garbage Collection Moving

Stanchina noted that garbage collection is moving back to the alleys beginning May 11, 2015.

## Place Making Workshop

Stanchina invited the City Council to a placemaking workshop that will be taking place at City Hall.

## **City Attorney Reports**

Pirkola explained the qualifications and process one must undertake to obtain a dock permit. He raised a concern regarding the misinterpretation of a permit as an easement. Moraska objected to the concept of issuing private dock permits off public land. Alessandrini and Revord inquired as to the viability of a municipal dock. It was concluded that the City Attorney would review this situation further.

## **Committee Reports**

Stanchina stated that the Labor Relations Committee needs to meet with the Department of Public Works Union Representatives to establish initial proposals and determine ground rules for negotiations.

#### **Council Member Privilege**

Blomquist informed the City Council of the status of the development of a dog park within the City as it was discussed by the Planning Commission.

Coe highlighted the need to ban non-City sponsored hunting within the city limits.

Alessandrini and Coe encouraged the public to vote in the election May 5, 2015.
