Minutes of the Regular Meeting of May 2, 2016

Millie Hill Mine Trail Erosion Control Project

Dr. Patrick Kennedy detailed his son Joe's proposed Eagle Scout project. He indicated that his son was absent due to his participation in a high school sporting event. Kennedy estimated that the cost of the project would be around \$700.

Stanchina imparted that the DPW may have extra materials available at the Department of Public Works facility. He conveyed that he would research any potential liability concerning the City.

It was moved by Revord and supported by List to authorize Joe Kennedy to repair five sites of erosion problems on the Millie Hill Mine Trail.

Motion Prevailed Unanimously

Authorization to Proceed with the City Property Timber Harvest

Stanchina reported on the outcome of the meeting between the Infrastructure Committee and Brock VanOss regarding the City's timber management plan. He recommended that the City proceed with the harvesting of the City property located on Millie Hill and Pine Mountain. Stanchina stated that a survey will have to be performed on the Pine Mountain property at an estimated cost of \$2,000. He confirmed that VanOss has been made aware of the mining-related issues in those areas.

It was moved by Alessandrini and supported by Coe to authorize Brock VanOss to prepare bid packages for the harvesting of timber on Pine Mountain and Millie Hill and to authorize the surveying of the Pine Mountain Property at a cost not to exceed \$2,000.

Approval of 80% City 20% Employee Funding Ratio Re: Health Insurance Premiums

Stanchina communicated that the City must pass a resolution regarding the funding of health insurance premiums annually. It was moved by Maule and supported by Revord to approve an 80% City 20% employee funding ratio for health insurance premiums.

Crystal Lake Boulevard Utility Project

Stanchina reviewed the timeline for the Crystal Lake Boulevard Utility Project.

Rubbish Drop off

Stanchina notified the City Council that approximately 200 residents took advantage of the rubbish drop off and that he would keep them informed of the tonnage that was collected once it was determined.

Stanchina clarified that the writing-off of delinquent personal property can only be performed by the Circuit Court and that it has been a while since this process was undertaken.

City Attorney Reports

Cavalieri informed the City Council that the grace period for the removal of the Withers Broadcasting Tower is due to expire in approximately two and a half weeks. Stanchina asserted that the City can disconnect the power to the tower once the grace period expires. Alessandrini suggested that a tower removal period be stipulated in the upcoming tower leases.
