## Discussion of Commercial Rehabilitation Act Proposed Certificate of Eligibility

Stanchina detailed the rationale, eligibility and projected outcomes of the Commercial Rehabilitation District. He noted that the Commercial Rehabilitation District and Downtown Development Authority boundaries would coincide. Stanchina suggested that a finite level of tax exemption be determined. Blomquist communicated that the goal of the program would be to improve the overall downtown area, not just individual projects.

It was moved by Alessandrini and supported by Blomquist to set a public hearing regarding the establishment of a Commercial Rehabilitation Act District on February 20, 2017, at 6:30 P.M.

### Introduce and Set Public Hearing for Zoning Ordinance (74-553) Text Amendment Re: Special Use Permits

Stanchina reviewed a text amendment to section 74-533 of the zoning ordinance that would allow a public hearing for a Special Use to be set at a special meeting of the Planning Commission and amend the minimum notice requirement from "five and not more than" to "15 days in advance" as to coincide with the Michigan Zoning Enabling Act.

It was moved by Maule and supported by List to set a public hearing for the amendment of Zoning Ordinance Section 74-533 on March 6, 2017, at 6:30 P.M.

## **Revised Credit Card Policy**

Stanchina indicated that the City's credit card has been compromised and unavailable, due to employee usage, on several occasions. He recommended that the Credit Card Policy be revised to include issuing an additional credit card with a \$5,000 limit to the Director of Police and Fire Services & Department of Public Works Supervisor.

It was moved by Stohl and supported by List to amend the Credit Card Policy to allow the Director of Police and Fire Services, Department of Public Works Supervisor and Chief Financial Officer to each be issued a credit card with a \$5,000 limit.

# **Equipment Adjustment on Fire Truck Purchase**

Stanchina conveyed that Director of Police and Fire Services Mattson, Deputy of Director of Fire Services Friedenstab, Captain DeBidart and Engineer Drago reviewed the fire truck plans and recommended that several items be adjusted due to increased functionality, resulting in a cost increase of \$2,191.

It was moved by Maule and supported by Blomquist to approve an additional \$2,191toward the purchase of a fire truck from Pierce Manufacturing, resulting in a total cost of \$492,013.
