## **Special Presentation**

*Representative Beau LaFave Legislative Update*

Representative Beau LaFave outlined some legislation being considered. Items included dark store legislation, F.O.I.A of State legislature and Executive branch documents, income tax rollback, SNAP benefit reform, and high school internship legislation. Council member questions and concerns were addressed. The subject of dark store legislation received some discussion.

### **Opening of Proposals Re: Master Plan Update**

Stanchina informed the Council that the City received no proposals. He suggested that the City could reevaluate the plan and contact firms who were sent proposals to inquire why they didn't submit. He also stated a potential option of sending the current plan to the Planning Commission to see if the current plan is still relevant.

## **New Business**

### **Approval to Repair Fire Engine #2**

Stanchina outlined the repairs needed to Engine #2. Stanchina explained that even if no repairs are done, the City would need to pay approximately \$4,000 to reassemble Engine #2 and without the repairs the City would not be able to sell Engine #2. Stanchina noted that based on his review of truck sales he believes the City can recoup the cost of the repairs.

It was moved by Alessandrini and supported by Maule to approve the repair of Fire Engine #2 at the cost of \$11,000.

Stanchina presented a request by Jenny Baker-Houtari, Family and Community Partnership Coordinator, to use the City Park Pavilion at no cost on May 19, 2017, for their annual "End of the Year Celebration."
