## **Public Hearing**

### **Payment in Lieu of Tax Ordinance Re: Commonwealth Development Central School Apartment Homes**

Mr. David Ritchay presented his reasoning for the 12% Payment in Lieu of Tax Ordinance. He voiced his confidence for the strength of the project's score.

Alessandrini opened the Public Hearing.

Michaud communicated his support for Commonwealth's project due to its positive impact on the School District and community.

### **City Park Playground Equipment MDNR Trust Fund Grant Application**

Stanchina detailed the replacement plan for the City Park playground equipment if a grant is received. The City Council discussed handicapped accessibility option of the City Park playground area. Celello suggested that the City submit a Michigan Municipal Risk Management Authority Risk Avoidance Program grant for the replacement of unsafe park equipment.

Alessandrini opened the Public Hearing.

## **Old Business**

### **Consideration of Payment in Lieu of Tax Ordinance Re: Commonwealth Development Central School Apartment Homes**

Ritchay explained the process by which the Michigan State Housing Development Authority approves projects. He confirmed that the project would self-score at 116 points with the higher walk score. Ritchay conveyed that it would be difficult to rent to non-low income people and that the IRS penalizes companies for renting at full rent without permission. He verified that the property could be sold but the income restrictions would stay with the facility. Ritchay indicated that construction would take a year and be performed by the same contractor.

Michaud estimated that the school is in deficit for \$258,000 and that if the building sells the deficit will be eliminated. He imparted that the School District spent \$60,000 last year on the former Central School facility for the minimum maintenance possible and that he expects that practice to continue if not sold.

Alessandrini voiced his disapproval for the proposed PILOT program due to traffic concerns and project transferability. Blomquist, Ceello and Michaud refuted Alessandrini's traffic concerns.

It was moved by Revord and supported by Stohl to authorize the Tax Exemption Ordinance for Commonwealth Development's Central School Apartment Homes project, as presented.
