### **Renewal of Property and Liability Insurance Re: MMRMA**

Stanchina conveyed that the City has used the Michigan Municipal Risk Management Authority for a number of years and has received a large refund due to the duration of membership and low claims. He verified that the refund money, which is being utilized for the self-funded portion of the City's liability insurance, is removable.

It was moved by Revord and supported by Alessandrini to renew the property and liability coverage with the Michigan Municipal Risk Management Authority for the period of July 1, 2017, to June 30, 2018, at a cost of \$82,534.

### **Appointment to the Zoning Board of Appeals Re: Mr. Rob Barkle**

Stanchina recommended the reappointment of Mr. Rob Barkle to the Zoning Board of Appeals. He highlighted a vacancy on the Board.

It was moved by Zemar and supported by Celello to appoint Mr. Rob Barkle to the Zoning Board of Appeals for a three-year term to expire on June 20, 2020.

### **Consideration of Resolution Re: New Voting Equipment**

Stanchina offered a resolution approving the procurement of new voting equipment through a Help America Vote Act grant.

It was moved by Alessandrini and supported by Zemar to adopt the "Resolution for New Voting Equipment," as presented.

### **Approval of Resolution Re: 80% Employer Contribution Cap for Health Insurance Premiums**

Stanchina presented a resolution approving a maximum employer contribution of 80% for employee health insurance premiums. He stressed that the approval of this resolution does not preclude the City from contributing less than 80% of health insurance premiums.

It was moved by Revord and supported by List to adopt the proposed "Resolution Authorizing Any City of Iron Mountain Employee Subject to The Terms of PA 152 of 2011 to Comply with Section 4 of PA152 of 2011, Referred to as The 80/20 Rule, Beginning July 1, 2014."

### **Approval of 2017/18 Fee Schedule**

Stanchina detailed the proposed changes to the fee schedule. Alessandrini suggested granting additional time to rental certificates that have successfully passed inspection on the first attempt in the past.

Blomquist imparted that one tenant could substantially affect the condition of a rental. Alessandrini noted that the excavation permit fee should be reviewed or relabeled and that the NSF fee is shown twice. He asserted the importance of blight control. Pirkola confirmed that there is a due process requirement within the City's blight ordinance.

It was moved by Alessandrini and supported by Blomquist to approve the proposed 2017-2018 Fee Schedule.

### **Approval of Kingsford High School Cross Country Meet Re: City Park Trails**

Stanchina stated that the cross country meet is a good use for City Park.

It was moved by List and supported by Maule to authorize the Kingsford High School cross country team to utilize City Park on September 12, 2017, from 1:30 P.M. to 6:00 P.M.

### **Approval of Donation Re: July 4<sup>th</sup> Fireworks Show**

Stanchina indicated that the City donates \$500 annually to the July 4<sup>th</sup> fireworks.

It was moved by Alessandrini and supported by Blomquist to donate \$500 to the Sons of the American Legion Squadron #50 for the July 4, 2017, fireworks.

### **Request to Purchase City-Owned Property**

Stanchina outlined a request by Jonathan Weimer of the Overland Group to purchase the southeast corner of the Khoury Property.

It was moved by Revord and supported by List to advance the sale of the southeast corner of City-owned property at the former Khoury Furniture factory to Jonathan Weimer of the Overland Group.
