### PARTICIPATING IN CITY COUNCIL MEETINGS IN CONFORMANCE WITH SOCIAL DISTANCING REQUIREMENTS

**VIRTUAL PARTICIPATION BY ZOOM VIDEO CONFERENCING** The City of Iron Mountain is now offering the ability to view and participate in Council meetings via video meetings and telephonic conferencing via “Zoom” video conferencing computer technology. #### **I don’t have a computer or smartphone; can I still use Zoom?**

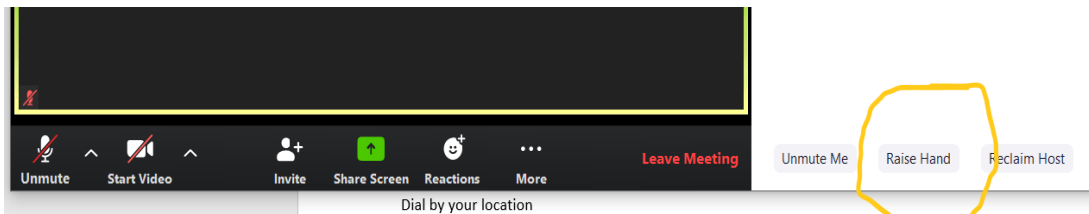

#### **How can I provide Public Comment on Zoom?**

Mayor Alessandrini will request public comment during the Public Comment periods on the agenda and during each Public Hearing. Once Mayor Alessandrini has announced the public comment period, please do one of the following.

#### USING A COMPUTER OR SMART PHONE:

- Click on the “Raise Hand” feature in the “Manage Participants”. This will notify City staff that you have raised your hand.



- City staff will unmute your microphone when it is your turn to provide public comment.
- A prompt will appear to confirm you would like to be unmuted. Once you accept the prompt, you will have five minutes to provide public comment.
- Once your public comment has ended, you will be muted again.

USING A REGULAR PHONE:

- Dial \*9 (star 9), this will notify City staff that you have “raised your hand” for public comment.
- City staff will unmute your microphone when it is your turn to provide public comment.
- You will hear “you are unmuted” and then you will have five minutes to provide public comment.
- Once your public comment has ended, you will be muted again.
